About low temperature automatic heating lithium iron phosphate battery

Low temperature heating function

charging: when the ambient temperature is lower than 0°C (32°F), the internal heating plate of the battery will automatically get heated to 10°C (50°F), our battery starts to charge automatically; discharge: when the ambient temperature is lower than -20° C (-4°F), the battery will automatically stop discharging, and the discharge function is automatically restored when the ambient temperature is higher than -10°C(14°F).

NOTE

- 1, Charging Temperature: -31°F (-35°C) to 122°F (50°C).
- 2, Discharge Temperature: -4°F(-20°C) to 140°F (60°C).
- 3, If it is a 4-string lithium iron battery pack, the charge protection voltage is 3.65V*4=14.6V, and the discharge protection voltage is 2.5V*4=10V.

How to charge the battery?

Scheme 1: You can use a lithium iron phosphate 4-string (14.6V) charger to charge the battery pack.

Scheme 2: You can use photovoltaic solar panels to charge the battery through MPPT.

Scheme 3: You can use the inverter to charge the battery pack (note: the inverter needs a built-in AC to DC charging function)

If the controller (MPPT) is used to charge the battery pack, the controller output is connected to the load electrical appliances (such as low-power light bulbs). In order to avoid triggering the battery's BMS protection after low current discharge, causing the battery pack to fail to restore output, it is recommended that the controller set the parameters as follows:

A. Charging protection voltage: 14.6V

B. Charging recovery voltage: 14.2V

C. Discharge protection voltage: 10V

D. Discharge recovery voltage: 10.8V

The above settings can ensure that the battery pack does not trigger the BMS protection. When an emergency occurs, the controller first triggers the protection, which can prolong the service life of the battery.









About connected in parallels and in series

Our Lifepo4 batteries can be connected in parallels and in series for larger capacity and voltage. Suggest Max connection in series: 4pcs batteries to 48V. Suggest Max connection in parallels: it can connect multiple batteries, suggest no more than 10pcs in parallel. Products of different manufacturers cannot be connected in series or in parallel. When the batteries are used in parallel or series, the voltage must be the same. It can support fast charging and solar panel charging.

Precautions:

- 1. When recharging, use the LiFePO4 battery charger specifically for that purpose.
- 2.Do not strike battery with any sharp edge parts, such as Ni-tabs, pins and needles.
- 3.Do not immerse the battery in water and seawater.
- 4.Do not use and leave the battery near a heat source as fire or heater.
- 5.Do not reverse the position and negative terminals.
- 6.Do not connect the battery to an electrical outlet.
- 7.Do not discard the battery in fire or heat it, Do not bend tab.
- 8. The battery tabs are not so stubborn especially for aluminum tab.
- 9.Do not short-circuit the battery by directly connecting the positive and negative terminal with metal object.
- 10.Do not transport and store the battery together with metal objects such as necklaces, hairpins etc.
- 11.Do not directly solder the battery and pierce the battery with a nail or other sharp object.

NOTE:

The battery should store in the product specification book stipulation temperature range. If the storage time exceeds 3 months, it is recommended that you charge the lithium iron phosphate battery. Otherwise, the service life of the battery may be affected. Discharge current: Do not surpass the biggest discharge current which in this specification. Discharge voltage: Do not be less than the lowest voltage which is in this specification. Discharge temperature: The discharge temperature is in according to this specification,

How to activate the battery's BMS?

When you follow any of these methods, your battery can be used normally.

- 1: Please use an 18V solar panel to directly charge the battery, so that the current does not need to pass through the controller and the BMS can be activated. (You also can use a 12V solar panel to activate the battery's BMS, it takes about 3 seconds to fully activate.)
- 2: You can use a 14.6V charger (with 0V charging function) to charge the battery, which can also activate the battery's BMS.
- 3: If you have another same battery, you can use these two batteries in parallel, which can also activate the battery's BMS (it takes about 3 seconds to fully activate). After the battery is activated, charging and discharging can be rescheduled.

Note:

- 1. When you receive the product, please read the product manual carefully, which contains the installation method, precautions and detailed warranty terms of the product.
- 2. When using it for the first time, please complete a cycle of deep discharge and full charge so that the battery capacity will be automatically corrected.
- 3. Every 1-3 months, the battery must complete at least one cycle of deep discharge and full charge, otherwise the battery may be damaged. If the battery is not used for more than 6 months, the battery may be damaged.



About our battery's BMS

The unique built-in battery management system (BMS) of our product's lithium battery can protect it from overcharge, deep discharge, overload, overheating and short circuit, and low self-discharge rate. Our BMS has a high temperature disconnect function. When the internal temperature of the battery reaches 75°C ($167^{\circ}F$), it will automatically disconnect to protect the battery. With overcharge and overdischarge protection functions, when the overcharge voltage exceeds 15V and the overdischarge voltage is lower than 8.8V, the battery will automatically disconnect. Our recommended charging voltage and discharging voltage are 14.6 \pm 0.2V and 10V, respectively. If the charging voltage is lower than 13.8V, the battery power (with a deviation of 1-2%) cannot be fully charged.

About our battery's cell

Lithium-ion batteries have high energy density and high average output voltage. The self-discharge is small and there is no memory effect. The wide operating temperature range is -20°C~60°C. Excellent cycle performance, fast charging and discharging, charging efficiency up to 100%, and high output power. long lasting. It does not contain toxic and hazardous substances and is called a green battery.


